## Junior League Characteristics

- Junior leagues cost is **\$250 plus tax (\$262.50)**. This includes the league and a junior membership for the season with unlimited play.
- League will start June 17<sup>th</sup> and will be every Tuesday for 7 weeks.
- Junior League for kids entering 5<sup>th</sup> to 8<sup>th</sup> grade is 8-10:00.
- Junior League for kids entering 9<sup>th</sup> grade and older is 9:30-12:00.
- League members must be able to walk 9 holes and carry their equipment themselves.
- Participants must have their own clubs.
- There is a 45-kid limit per session.
- Watch for optional Junior/Adult tournaments to be announced in the future.
